I understand that bicycling and the use of the Equipment involve a risk of injury. I voluntarily assume and accept any risks of injury, damage or loss to the user/users which may be sustained as a result of, connected with, or in any way associated with use of the Equipment. I understand that bicycle protective gear such as helmets are recommended, but they do not eliminate the risk and may not reduce the risk of injury in the event of an accident.

2. Doolin Rent a Bike shall not be liable for, nor shall it accept responsibility for, any injury, loss or damage howsoever sustained by any person or persons, whether direct or indirect and including consequential losses arising out of use of the Equipment or in any way whatsoever which does not arise from any negligent act or omission of Doolin Rent A Bike.

3. I fully and irrevocably indemnify, hold harmless and defend Doolin Rent A Bike, to the extent permissible under applicable law, against any and all liabilities, claims, and causes of action resulting from injuries, damages or loss (including, but not limited to, costs which may be incurred in any legal action) sustained by me arising from my use of the Equipment.

4. The Equipment, at all times, remains the exclusive property of the bicycle shop. I am responsible for damage to or loss of the Equipment. I agree that if the Equipment is lost, destroyed or damaged beyond repair in the judgment of the bicycle shop, I will pay the bicycle shop the value of the Equipment. All repairs needed as a result of the use of, or any damage to, the Equipment will be performed at the standard rates in place at Doolin Rent A Bike at the time of repair and the cost of such repairs, including all necessary parts required as a result of damage, shall be paid by me. Any part of the Equipment not returned by close of business on the return date will be liable for a late return fee of €15 for each day or part of a day after the return date until the Equipment is returned.

5. Doolin Rent A Bike, to the greatest extent permissible under applicable law, provides no warranties, express or implied, and this equipment is accepted "as is."
